The Marshall County Board of Education met in regular session Tuesday, May 14, 2019, 6:30 p.m., at the Board of Education Office, all members having been notified of business to be considered.

Present were: President John Miller, Vice President Christie Robison, Members Brenda Coffield, Lori E. Kestner, Dr. Duane Miller; Secretary Stanley Stewart and Members of the County Administrative Staff.

The Board recognized and presented certificates to 19 retirees for the 2018-19 school year.

Claire Hagan commended the Board for completion of the playground and expressed appreciation of the Sand Hill Community. Ms. Hagan addressed extreme concern regarding hardships created due to the early starting time of the school. She compared various starting times for other schools and alluded to the unfairness issue.

Cassie Daugherty also addressed the Board with similar concerns. She indicated that her children could not participate in sports due to the timing issue. She also reiterated that her children should be given similar opportunities to participate in school functions and activities.
