Mrs. Hartley reviewed the Financial Statement ending April 30, 2020.

Superintendent's Reports:

We have begun ramping up Pearson Vue testing while still using many precautions. Since reopening the site, 17 tests have been administered. These TASC tests assist with student graduation and employment. Testing is also available for WV Insurance Agencies, Ohio Educator assessment, Pennsylvania Educator assessments and the American Society for Nondestructive Testing. There are 10 tests scheduled for this week and we will add testing for WV State Pharmacy. Mr. Wilson has done a great job expanding these options.

We are working with the WVDE to complete a survey for assessing broadband connectivity. In addition to that survey, teachers are entering information for each child in their class as to their access to devices, cell service, etc. This will helpfully give a clear picture of needs across the state.

Dr. Haines has represented Marshall County Schools on two online training events in the past few weeks. She was a guest speaker for the Autism Society of America, as well as Education Alliance EDTalks. During both of these sessions, the work of Marshall County School employees during this pandemic was highlighted. Thousand of viewers watched each broadcast.

Dr. Haines is serving on a re-entry committee for the WVDE. The first meeting was today. You will see many options and resources to support re-entry in West Virginia.

On behalf of the WVEA, Matt Mandarino presented the Board of Education a resolution entitled "School Board Resolution: We Rise Together." This resolution was signed by each board member.
